**ORDINANCE NO. 13-13
An Ordinance Amending Chapter 243
Parks And Recreation Areas Schedule B Recreation Department Fees**

BE IT ORDAINED by the Mayor and Council of the Borough of Westwood as follows:

All applicants requesting use of Borough parks and fields shall be required, prior to the commencement of the activity, to pay the fee set forth in "Schedule B" annexed hereto. All fees shall be payable to and processed by the Recreation Department.

If any section, subsection, part, clause or phrase of this Ordinance shall be declared invalid by judgment of any court of competent jurisdiction, such section, subsection, part, clause or phrase shall be deemed to be severable from the remainder of this Ordinance.

This Ordinance shall take effect immediately upon final passage and publication as required by law.
